Summary of Last Meeting

There was no business arising from previous minutes.

Revised Policing & AFP Withdrawal

Australian Federal Police withdrew from the Alice Springs Airport on 14th February. All policies, procedures and documents have had to be reviewed. NT Police started as our law enforcement agency on February 15th. NT Police have been trained and familiarised with the Airport and will be called to attend if required.

Alice Springs Airport was reclassified to a Category 3 Airport by the Office of Transport & Security so are no longer 1 of the 11 Designated Airports. The processes that take place at the Security Screening Point are dictated by the government and not chosen by the Airport.

Apron Overlay Project

A presentation was shown about the currently Apron Overlay project. It has been 21 years since it was last done. Airfield lighting installed in the 60's is being replaced and some expansion on some taxiways and aprons. It is expected for the most of the work to be complete by April 30th.
